The Minister



Minister Naadir Hassan was appointed at the helm of the Ministry of Finance, Economic Planning and Trade in November 2020. He is 39 years old and one of the youngest ministers to be appointed in the position.

Minister Hassan is familiar to most staff of the ministry, as his first job was with the ministry. He then moved to the Central Bank of Seychelles and just before his appointment he was working with telecommunications company, Cable & Wireless.

His career is in financing, banking and economics.

Minister Hassan brings in a new energy within the Ministry, where he consults and acknowledges the hard work of his staff.

"In our ministry, we have a workforce that is hard working, motivated and very professional. They should be valued and we all should work as a team. We are a team and everyone should feel part of the team. That is how I want the Ministry to move forward as we have a key role to play to ensure financial and economic stability in our country."

Financial Sector - Ministry playing its role to ensure Seychelles meets its international obligations

Seychelles has met the deadline given by the Eastern Southern Africa Anti Money Laundering Group (ESAAMLG) to submit its report for re-rating at the ESAAMLG Plenary in September 2021, in order for the jurisdiction to be in compliance with international standards, established by the Financial Action Task Force (FAFT).

In early March, the National Assembly approved six bills addressing concerns raised by the two international organisations, five of which were presented by Minister Naadir Hassan.

Amendments were approved to the following bills:

- · Anti-Money Laundering and Countering the Financing of Terrorism (Amendment) Bill, 2021
- · Beneficial Ownership (Amendment) Bill, 2021
- · Mutual Assistance in Criminal Matters (Amendment) Bill, 2021
 - · Extradition (Amendment) Bill, 2021
- · International Trusts (Amendment) Bill, 2021
- · Prevention of Terrorism (Amendment) Bill, 2021

ESAAMLG, as the FATF-style regional body tasked with ensuring compliance and implementation of the FATF Recommendations, adopted Seychelles' Mutual Evaluation Report in 2018, and it was determined that Seychelles was 'compliant' or 'largely compliant' to only 20 of the 40 FATF Recommendations. Seychelles was determined

'partially compliant' on 16 Recommendations and 'non-compliant' on 4 Recommendations.

Seychelles' national effort to honour all its international obligations, is spearheaded by the National Anti-Money Laundering and Countering the Financing of Terrorism Committee, commonly known as NAC. Its chairperson is the Secretary of State within our ministry, Patrick Payet.

To further provide support to the financial sector, it is in Ministry's vision, to create a division in its new structure which will be in charge of coordinating the development of the sector. The Ministry has also created a Financial Services Reforms Committee which met for the first time on the 27th of April 2021 with the main objective to develop the Financial Sector Strategy for Seychelles.

are facing, especially on their operation and how best to overcome and move forward.

The participants have expressed their support for the forum, as it will allow them to build trust amongst each other, which will improve their working relationship, not only between the heads but among the entities.

The meeting is the first in a series that the Ministry is organizing, to ensure a commonality of purpose and delivery for all entities under its purview.

Important dates

- * **16th February 2021:** The Budget 2021 speech was delivered.
- * 24th February 2021: The National Assembly approved the general merit (2nd Reading) of the Appropriation Bill 2021.
- * 25th February 2021: National Assembly enters into Committee Stage to discuss and vote on the allocated sum of each budget dependent entity.
- * **02nd & 5**th March 2021: Six AML/CFT bills, in which 5 were presented by Minister Naadir Hassan and approved by the National Assembly.
- * 07th/09th April 2021: The Ministry of Finance defended its budget and that of oth-

er entities under its purview before the National Assembly.

- * 13th April 2021: The National Assembly took the final vote on the Appropriation Bill 2021.
- * **26th April:** Department of Trade marked World Intellectual Property Day.
