Fitch Ratings upgrades Seychelles to B+: Outlook Positive

The rating agency, Fitch Ratings has upgraded Seychelles country rating, from B+; Outlook Stable to B+: Outlook Positive.

The new revision, published on 13th May, 2022, came only five days, after the IMF Mission had completed its 2nd review of the country's economic reform programme, under the Extended Fund Facility Arrangement, signed in July 2021.

The Minister for Finance, National Planning and Trade, Naadir Hassan, has welcomed

the new status.

"The revised rating from Fitch, shows that all the fiscal and monetary policies the government and Central Bank of Seychelles, have taken thus far, to achieve our economic reform targets, have been the right ones. Since the start of the reforms in July 2021, we have been prudent with spending, we have demonstrated that we are serious in reducing the country's debts, and we have shown our drive to bring in, the necessary structural reforms, needed to achieve these targets."
