September — a busy month

It has been a busy couple of weeks for the Ministry, playing host to several national and international partners, as well as for the budget team, who are putting the finishing touches to the 2023 budget.

Integrated Planning and Integrated Toolkit training

In early September, the National Planning Department hosted a delegation from the United Nations Economic Commission for Africa (ECA). The delegation was in the country, to conduct a three-day training workshop, on the Integrated Planning and Integrated Toolkit, an important instrument in enabling countries to align global and continental agendas, such as Agenda 2063 and Agenda 2030, to their National Development Plans.

Agenda 2063—Validation workshop

The National Planning also hosted a validation workshop in the middle of the month, bringing together local stakeholders to evaluate and validate the draft report of Seychelles' First Ten Year Implementation Plan' (FTYIP), for the Agenda 2063.

The final National Consultative Report for Seychelles focusing on the 'First Ten Year of the Implementation Plan of the Agenda 2063' was expected to be submitted to the African Union Commission, at the end of September.

During that same workshop, the ground-work for the preparation of the 'Second Ten Year Implementation Plan for Agenda 2063', got underway.

VAT Assessment

A team from the Fiscal Affairs department of the International Monetary Fund (IMF), was also in the country, earlier this month, conducting an assessment on the implementation of the Value Added Tax regime.

After meeting with local stakeholders, the team presented their preliminary findings to the ministry and the Sey-



chelles Revenue Commission (SRC).

The final report is due soon.

Budget 2023

For the budget team, it is the time of the year, where they are tidying up the country's budget, for the year ahead.

The final document is to be presented to the cabinet on 05th October.

The 2023 budget will be presented before the National Assembly, in November.

Mid-Year Review

Even though the final touches are being put into place for the Budget 2023, the ministry, still had to prepare and present the Mid-Year Economic and Fiscal Outlook for 2022 before the National Assembly.

The mid-year review was presented to the National Assembly on Wednesday 21st September. The 2022 budget has had a budget cut of SR 887,451,324.04, though around half has been reallocated through a Supplementary Estimate of SR 472,807,404.81, which was approved.

IMF mission—3rd EFF Review

Finally, at the time of publishing, the Ministry is hosting the IMF team, conducting its 3rd Review under the Extended Fund Facility (EFF) Arrangement.

Debt Management Office has published several documents, so far this year

The Debt Management Office, has published several documents, this year, as part of the Ministry's drive to be more transparent.

The office, comprising of five staff, has published quarterly debt bulletins, which show the total Government and Government guaranteed debt at the end of each quarter.

The quarterly Issuance Plan of Government Securities are also accessible to the public. The document gives the indicative Issuance Calendar of Treasury Bills and Treasury Bonds for each quarter.

At the beginning of October, the Debt Management Office published the 2022 Annual Borrowing Plan, a detailed document describing how the annual financing needs will be met during the budget year.



The compilation and publication of the reports are as per the Extended Fund Facility Arrangement, signed between the Government of Seychelles and the International Monetary Fund (IMF), in July, 2021.

The Mandela Washington Fellowship for Young African Leaders — the flagship program of the U.S. Government's Young African Leaders Initiative (YALI) — was created in 2014 to invest in the next generation of African leaders. Since 2014, nearly 5,800 young leaders from every country in Sub-Saharan Africa have participated in the Fellowship. The Fellows, between the ages of 25 and 35, are accomplished leaders and have established records of promoting innovation and positive impact in their communities and countries.

During the Fellowship, the Fellows participate in six-week Leadership Institutes, studying Business, Civic Engagement, or Public Management hosted by U.S. colleges or universities. Throughout the Institutes, Fellows enrich local U.S. communities while sharing best practices.



I had applied for the Public Management track and was placed at Texas Tech University in Lubbock, Texas. This programme was the best fit for me with my current work experience in Government.

The Fellowship as very rich and included not only engaging academic sessions on im-


