FitchRatings upgrades country outlook

FitchRatings has upgraded Seychelles Outlook from B+ to BB-: Outlook Stable. The new upgrade by FitchRatings was issued on Friday 21st October, 2022. The Minister for Finance, National Planning and Trade, Naadir Hassan, has welcomed the upgrade, saying 'for the past two years, the government has had its hand full, to get the country's economic and financial situation back on track.'

'Strong economic recovery continues in 2022', says IMF



The Executive Board of IMF has endorsed the third staff level review of the Seychelles economic programme performance conducted in late September and early October.

With the endorsement, the Seychelles Government will draw about \$8.6 million, under the EFF. Up to now, the total disbursements under the programme, are \$80.6 million.

Minister Hassan has welcomed the endorsement.

"This endorsement of the implementation of the economic reform programme by the IMF Executive Board, is yet another indication that the decisions of the government have so far proven to be the right ones and most importantly the actions taken have been responsible, and are setting the foundation for a prosperous Seychelles."

Seychelles and IMF agreed on an economic reform programme under the Extended Fund Facility at the end of July, 2021, because of the devastating impact of the COVID 19 pandemic on the country's economy.

Ministry launches online auction sale website

The auction sale of government's assets are now being conducted online, following the launch of the website: https://auction.finance.gov.sc./

The first online sale was conducted in late October, whereby 15 government vehicles were on auction. The platform only goes live when there is an auction sale to be held.

Seychelles takes the chair of the UNECA Sub-Regional Office for Eastern Africa



In mid November, Seychelles hosted the 26th joint meeting of the Intergovernmental Committee of Senior Officials and Experts (ICSOE) of the United Nations Economic Commission for Africa (Uneca) Sub-Regional Offices for Eastern and Central Africa.

The conference was officially opened by the Minister for Finance, National Planning and Trade, Naadir Hassan.

During the conference, Seychelles was elected as chair of the Sub-Regional Office for Eastern Africa. The chairmanship is for one year.

The three-day meeting was held under the theme 'Pursuing resilience, economic growth and diversification in the context of instability and shocks: Role of Special Economic Zones, Innovative Finance and African Continental Free Trade Area (AfCFTA).'

The conference was facilitated by the Department of National Planning.

IPR - Department of Trade hosts key stakeholders



The Trade Department hosted a meeting of local key stakeholders handling Intellectual Property Rights, in October, to address issues concerning certain types of counterfeit goods that are entering the country as well as protection of registered intellectual property rights in Seychelles.

The stakeholders agreed that whilst Seychelles have laws which protect Intellectual Property Rights (IPRs) nationally, mainly the Industrial Property Act 2014, the Copyright Act of 2014 and S.I 42 of 2014 of the Customs Management Regulations, nonetheless, implementation and enforcement remain a challenge and as a consequence there exist an urgency to enhance existing frameworks and capacity, to tackle the issue of counterfeit goods, in particular for goods that may carry risks to the health and safety of consumers.

The meeting was chaired by the new Principal Secretary for Trade, Francis Lebon, who was appointed in September, replacing Mr. Ronald Cafrine.

Trade Department is represented at the ARIPO communications training on IP



Senior Trade Officer, Aissata Dia, represented the Trade Department at the first ever communications training on Intellectual Property which was organised by the African Regional Intellectual Property Organization (ARIPO) and the Intellectual Property Rights and Innovation Project in Africa (AfrIPI), between 08th and 10th November, in Harare, Zimbabwe.

The objective of this training was to build the capacity of the participants to understand intellectual property issues and raise IP awareness among various stakeholders.

Debt Management Division to migrate to a new debt management software in 2023



The Debt Management Division, in the Ministry of Finance, National Planning and Trade intends to migrate to a new debt management software, known as the 'Meridian Commonwealth' by April 2023.

The Division is getting the technical assistance from the Commonwealth.

Recently, a Commonwealth Technical Assistant, Mrs. Joanne Allin, conducted a one-week introductory meeting with all the relevant stakeholders to discuss the migration from the current Commonwealth Secretariat Debt Recording and Management System (CS DRMS) to the "Meridian" recording system.

The expected outcome of such a meeting was to acquire the necessary inputs from the aforementioned stakeholders as they will be able to access the Meridian on a limited basis in order to ease the transfer and use of information to and from the Debt Management Division.

In the meantime, the Debt Management Division has issued the Government's Annual Borrowing Plan for the year 2023.

Ingredients &

750 ml bottle full-bodied dry red wine such as Merfot, Spanish Garnache, or Pinot

1/2 cup simple syrup see Notes below
1 cup fresh orange juice
1 cup unsweetened pineapple juice
2 oz. orange liqueur such as Cointreau

2 oz. brandy

2 cups fresh seasonal fruit whole, sliced or chopped, such as oranges, lemon, apple, pear, plum, raspberries,





INSTRUCTIONS

- Combine the wine, simple syrup, orange and pineapple juice, rum, brandy, and orange liquere in a large glass pitcher. Cover and refrigerate for at least 12 hours or up to 24 hours.
- Fill wine glasses with ice and arrange ¼ cup of the chopped fruit in each. Pour the sangria into the glasses, top with a splash of Prosecco, if desired.
- Garnish with seasonal fruit.
